I. STATE OF THE SOCIETY ADDRESS

To: Members of the International Society of Heterocyclic Chemistry  
From: Wolfgang Pfleiderer

It is my pleasure to inform the membership at large that the state of our Society is still very good and has continued to improve in recent years in many respects such as the financial situation, the international recognition and the efficiency in handling internal and external affairs. Due to the activity of our present Secretary-General of the Society, Professor Kappe and his well organized office, all problems and duties could be solved effectively in time.

During my presidency, the Society sponsored and conducted another very successful International Congress at the Hoshi University of Tokyo in Japan this summer, which turned out to be so far the largest congress of its kind in the 15 year history of the Society. Most credit has to be given to the local organizing committee headed by Profs. Kametani, Ban, and Kanaoka as well as the large crew of nameless colleagues and students to run a perfect meeting which attracted 1308 active participants from 35 different countries all over the world. Eleven plenary lectures, 180 contributed oral and another 240 poster presentations reveal the vital interest and activities in heterocyclic chemistry in general. The Society is also indebted to the tremendous response from industry in contributing financially and scientifically so effectively to the Congress.

It was also a great privilege to me to hand over the Second International Award in Heterocyclic Chemistry to Professor Raymond N. Castle at the Congress in recognition of his service to the Society and of his meritorious scientific contributions in the field of heterocycles. Our warm appreciation is given to Warner Lambert-Parke Davis for the financial support of this award.

I should like at this time, to encourage all members of the Society to send complete applications for the Third Award directly to Prof. Kappe not later than March 1, 1984. In fact, the selection committee will make a first decision from which the anonymous nominating committee will find the next awardee.

I should also like to take the opportunity to thank all officers of the Executive and Advisory Committee including my colleague Prof. R. R. Schmidt, the International Membership Chairman, for their support, help, and work during my tenure as President of the Society.

A very special personal concern is focussed on the method of recruiting new members for the Society, since this matter seems to be only successful, if, in personal contacts, a potential new member is persuaded to join the ISHC. This seems like an appropriate time to encourage all active members to take part in this action of winning at least one new member per year for the benefit of our Society.

V. Nominations for the Third International Award in Heterocyclic Chemistry to be presented at the 10th International Congress of Heterocyclic Chemistry in 1985 in Canada:

Any member of the Society may submit one nomination for the award. Each nomination must be accompanied by a biographical sketch of the nominee (including date of birth) and a list of ten of the nominee's most outstanding publications.

The nomination must be accompanied by a letter in which the nominee's accomplishments are succinctly presented and evaluated. The nominator should highlight the nominee's contributions that are of particular significance to theory or practice. The analysis of patents is especially valuable when appropriate. If the nominee is not the sole author of the publications listed or evaluated, his or her contributions should be specified. Seconding letters are not necessary but may be included. Reprints and/or preprints may be submitted but these must be strictly limited to two or three of the nominee's most outstanding publications. A useful criterion for the desirability of the submission of reprints is the likely availability of the publications to the Nominating and Selection Committees. Nomination of candidates previously nominated is encouraged. However, nominations are not extended automatically.

Eligibility: The award is open to any scientist whose research has directly or indirectly had a significant impact on heterocyclic chemistry. Other types of accomplishments (such as a new use for heterocyclic compounds in, for example, drugs, herbicides, etc.) and research teams as sharers of the award are not excluded. In evaluating the nominees, emphasis will be placed on (a) the heterocyclic chemistry aspects of the accomplishments, (b) the recent contributions of the nominee, and (c) less honored scientists whose accomplishments have not already been adequately recognized in the form of other honors.
